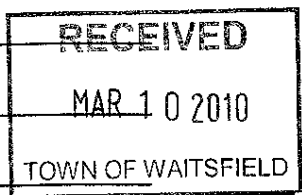


## Town of Waitsfield


