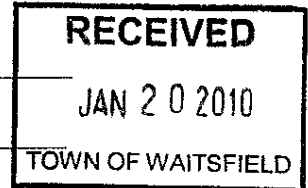


### Town of Waitsfield Application for Public Festival Permit
